Excel™ (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, delamination, and no color change to purple for as long as the original customer owns the vehicle.

Performer™ (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, demetallization, and delamination for as long as the original customer owns the vehicle.

Impulse™ (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, demetallization, and delamination for as long as the original customer owns the vehicle.

Metallic™ (Lifetime Limited Warranty) ASWF warrants against fading, peeling, cracking, adhesive failure, demetallization, and delamination for as long as the original customer owns the vehicle.

Retro™ (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, and delamination for as long as the original customer owns the vehicle.

Dimension™ (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, and delamination for as long as the original customer owns the vehicle.
